Subject: Request for expressions of interest for the supply of 2.000 kg. of phase change material (PCM)

1. INTRODUCTION

With the present notice we would like to inform that we are starting a market investigation in order to identify, in accordance to the principles of free competition, equal treatment, non-discrimination and transparency, the economic operators interested in expressing their will to participate to the awarding procedure for the supply indicated at point 2 herebelow, as part of the project for the construction of the new Innovative Energy Systems Laboratory at Tirreno Power, of which prof. Alberto Traverso is scientific director.

2. SUBJECT, PRESUMED AMOUNT OF THE SUPPLY, DURATION.

The awarding procedure relates to the following:

supply of 2.000 kg. phase change material (PCM) to be used to fill the thermal energy storage (TES) component. The presumed amount for the supply as above described is identified in € 15.000,00, plus VAT.

The activity referred to in the object must be completed until 4 weeks after the emission of order.

3. REQUIREMENTS

It is understood that the request does not constitute proof of possession of the requisites for the assignment of the services, which instead must be declared by the interested party and ascertained by the contracting station for the subjects invited on the occasion of the awarding procedure.

5. EXAMINATION AND POSSIBLE SELECTION OF APPLICATIONS

The requests received will be examined by the single Process Supervisor (hereinafter RUP), who will verify compliance with the requirements of this notice.

6. PROCESSING OF PERSONAL DATA

By sending the expression of interest, the economic operator declares, pursuant to EU Regulation 2016/679 - GDPR, to be informed that:
